#### 7. JUSTICE FOR WIDOWS - A SOLUTION

On 7 November the Government announced that it would change the rules which require some Armed Forces widows to forfeit their pensions on remarriage or cohabitation. From 1 April 2015 the rules of the various Armed Forces pension schemes will be harmonised so that all widows will be able to keep their pensions regardless of whether they remarry or not.

This announcement is excellent news. It effectively meets all the objectives of the Forces Pension Society Justice for Widows Campaign. It means that all widows currently in receipt of a families pension under the Armed Forces Pension Scheme 75 (AFPS 75) and all war widows receiving a pension under the War Pensions Scheme, and all those who may yet become widows will henceforth have the freedom of action which they all deserve, unfettered by artificial constraints which belong to another age. They will all be able to retain their Armed Forces pension for life.

The Government has also acknowledged that the Armed Forces Covenant lay at the heart of this issue and in solving the problem has fulfilled its pledge to honour the Covenant. Michael Fallon, the Defence Secretary said:

"It's vital that we do right by those who put their lives on the line for their country – that's why this Government enshrined the Armed Forces Covenant in law. These changes reflect the huge commitment which service families make to our country. We recognise that the unique nature of service life has left widows, widowers and surviving civil partners of members of the Armed Forces at a disadvantage. I'm delighted as Defence Secretary to be able to put right an issue that has caused upset and disappointment for many years."

The Society has in response issued a statement from the General Secretary Major General John Moore-Bick:

"We thank the Government for recognising the merits of our Justice for Forces Widows campaign and for putting right the unfair rules that were disadvantaging spouses and partners."

This change will come into force in conjunction with the launch of the new Armed Forces Pension Scheme 15. The change will not however lead to the reinstatement of pensions for those who have already forfeited them. This is because this would have required retrospective action, the cost of which would have been both additional and difficult to quantify. Such action would also have breached a principle held dear by governments of all persuasions and one which has been a consistent sticking point over many years. The

Forces Pension Society has accepted this limitation and indeed campaigned transparently on the basis of harmonisation, rather than retrospection.

There is however some good news which will benefit many who have already lost their pensions:

- From 1 April 15 the means test used to decide whether AFPS '75 pensions will be restored will be
  abolished. So, if a second or subsequent relationship ends for a member who has given up his or
  her pension on remarriage or cohabitation, restoration will be made without means test. Over half of
  current applications are refused.
- For those members who have previously applied for restoration of their AFPS '75 pension and were refused under the means test (effectively going back to the commencement of the scheme), and who are not in a marriage or cohabiting on 1 April 15, if they reapply, Veterans UK will restore their pension on 1 April 15. This will probably benefit between 300 to 600 individuals.

What has been achieved is significant, with the potential to affect many thousands of people. Precisely how many is difficult to quantify, because the beneficiary population is subject to constant change. Currently there are some 65,000 Armed Forces widows who stand to benefit, but there are also thousands of "widows in waiting" who will also benefit in due course. The Government Actuary's department has stated that the "old" rules affected the "vast majority of Armed Forces widows". The old rules also affected about half of those personnel still serving in the Armed Forces and would have continued to bite for the next 40 or so years until the affected population died out. In all some 400,000 people stand to benefit from this change. Of course, not all widows or widowers find another permanent partner; available statistics suggests that only some 0.1% of the affected widows' population have done so annually, but the great change is that they all now have the freedom to seek happiness afresh with someone else, rather than shunning relationships for fear of the consequences. However – a word of warning if you are affected by the change in rules; the rule change only becomes effective on 1 April 2015. Whilst the authorities may be unlikely to enforce the rules vigorously in the interim, an unequivocal breach such as a marriage might be hard to ignore. So don't take a chance. The lifeboat has picked you up - don't throw yourself overboard before it has docked. The Forces Pensions Society thanks all those who have assisted our campaign for change over many years. We also thank the government and Prime Minister for being prepared to examine the matter against the Covenant in the light of the logic and fairness of the case and to decide accordingly.

### 8. A CHRISTMAS SCAM!

With Christmas fast approaching you may wish to know Royal Mail and Trading Standards are alerting people to the following scam:

A card is posted through your door from a company called PDS (Parcel Delivery Service) suggesting that they were unable to deliver a parcel and that you need to contact them on 0906 6611911 (a Premium rate number). If you call the number and you start to hear a recorded message you will already have been billed £315 for the phone call. They are an iconic team, one of several representing the excellence of the Royal Air Force in the UK and around the world. Sqn Ldr Ruth Shackleton, Red Arrows Team Manager, said: "Mike Rondot's magnificent painting not only captures the excitement of the Red Arrows brilliantly and celebrates the team's 50th display season, but it also provides a wonderful opportunity to raise vital funds for the Royal Air Forces Association. We hope the public will wish to purchase this unique limited edition print as a splendid reminder of the world's most famous display team."

The picture was painted by well-known aviation artist, Michael Rondot. He said: "Sqn Ldr Jim Turner, the team leader, knows my style of painting from the days we flew Jaguars together. **Group Captain J F Monahan OBE DFC** to be Commandant Central Flying School, Royal Air Force Cranwell in March 2016 in succession to Group Captain J H Hunter.

**Establishment of 54 Signals Unit - RAF Digby** The Air Electronic Surveillance (ES) Pillar was established in 2011 under the subordination of Commandant Air Warfare Centre. The Unit operates from RAF Digby, providing mission support and ground Processing, Exploitation, and Dissemination (PED) of all UK airderived ES data and material from partner nations, in coordination with the Joint Electronic Surveillance Centre (JESC). The change in subordination is intended to align with other ISTAR PED elements but will not affect day-to-day operation and outputs.

The re-designation to 54 SU will ensure a strong Unit identity and acknowledges the maintenance of historic links to RAF Digby. 54 SU was originally formed at RAF Selatar in 1964 in response to the Indonesia-Malaysia confrontation (1962-1966). It was moved to RAF Digby in 1969 where the Unit saw regular deployments to Germany, Cyprus, British Honduras (Belize) and UK sites. In 1977, 54 SU was once again redeployed to Celle in Germany, where it stayed until disbandment in October 1992. With its rich operational heritage and ties to RAF Digby, it is deemed appropriate that the 54 SU number plate and badge should be re-established for use in an active intelligence unit supporting strategic operations around the world.

## **Goodbye Bastion**

As British troops leave Camp Bastion, marking the end of UK combat operations in Helmand, it is a time to reflect on the military effort over the last 8 years in Helmand. Camp Bastion was just a patch of sand with a few tents in 2005 and the thought of air conditioning was a distant dream. In 2006, construction began at the camp in order to support the changing role of UK operations in Afghanistan. Designed by Royal Engineers and built by them using a team of military engineers and contractors. By 2007, engineering construction of the runway and hospital was underway. As operations in Afghanistan evolved, so did the camp. It developed almost organically and the camp grew to meet the needs of the troops. From relatively humble beginnings, Bastion grew into a very large joint base which has been vital for sustaining, protecting and enabling combat operations in Helmand and beyond. The RAF has been at the heart of this endeavour and Deputy Commander Operations recently paid tribute to the all personnel who served there.

At the forefront has been the constant and sometimes heavy drumbeat of air operations, both strategic and tactical, and the Force Protection force elements that have ensured the security of the Base; however, ATC, Fire, Logistics Support, Movers, Medics and a host of others from every branch and trade across the Whole Force have made Bastion both a safe and an effective hub from which to launch and recover combat operations and personnel.

During this time, there were 600 fixed and rotary wing movements a day and newspapers reported it as being the fifth busiest UK operated airfield. Camp Bastion had 3 huge dining facilities each capable of feeding around 7,000 diners. It also had a Pizza Hut, KFC and even its own water bottling plant sucking up water from 300 feet below the Helmand desert, tapping into water that once fell as snow on the Hindu Kush mountain range. It became so huge some newspapers compared its size to the size of Reading. Many RAF personnel have served or travelled through Bastion, which is now firmly enshrined in the RAFs history.

**F-35 Lightning II Purchase**. Defence Secretary Michael Fallon has announced that the Ministry of Defence has reached an agreement in principle on an order for the first production batch of four Lightning II stealth combat aircraft. The aircraft will operate from both the Royal Navy's new aircraft carriers



It is expected that a formal contract for the F-35B aircraft will be in place within weeks. The contract will form part of the MOD's investment in Lightning II over the next 5 years to procure an initial 14 of these multirole fifth generation aircraft, together with the necessary support arrangements and infrastructure.

The UK has already taken delivery of three Lightning II aircraft, with another one due to be delivered in 2016. These are being used for testing and evaluation and are currently in the US. The UK's first operational Squadron in the UK will be based at RAF Marham in Norfolk in 2018, which will become their Main Operating Base.

**MOD** contract to update and sustain military air traffic management - AQUILA, a joint venture between Thales and NATS, has been awarded the £1.5 billion contract, which is expected to save the taxpayer up to £1 billion over the next 22 years. This includes a £400 million investment in advanced surveillance radars and a wide range of sophisticated equipment such as navigation aids and radios.

RAF Lossiemouth Accommodation and Support Facilities. Turner Estate Solutions has taken on a £23million contract to build new accommodation and support facilities at RAF Lossiemouth to help enable Typhoon fast jets to operate from the base. The contract has been awarded by the DIO. Turner will

undertake the work in around 14 months, building on £17 million of works already in progress. Earlier this year two squadrons from RAF Leuchars – Nos 1 and 6 – relocated to RAF Lossiemouth. They will be joined by 2 Squadron next April.

Advanced Short-Range Air-to-Air Missile (ASRAAM). A £40m contract has been signed with MBDA, who designed and manufactured the ASRAAM, which will provide support infrastructure and maintenance for the weapon for the next five years. The deal will sustain missile technicians, logistic specialists, field and design engineers and procurement specialists at the company's factories at Lostock in Greater Manchester, Stevenage in Hertfordshire and in Bedfordshire.
